Overview of the Board

Introduction:

Biological diversity is the variability among living organisms from all sources including terrestrial, marine and other aquatic ecosystems and the ecological complexes of which they are part; this include diversity within species, between species and of ecosystems. In short, Biodiversity is the vast array of all the plants, animals, insects and micro-organisms inhabiting the earth either in the aquatic or terrestrial habitats. The human civilization depends directly or indirectly upon this biodiversity for their very basic needs of survivalfood, fodder, fuel, fibre, fertilizer, timber, liquor, rubber, leather, medicines and several raw materials. This diversity is the condition for the long term sustainability of the environment, continuity of life on earth and the maintenance of its integrity. People are now aware of the fact that habitat degradation, loss of wild stock is association with loss of local traditional knowledge led to rapid degradation of biological resources all over the globe.

The growing concerns for depletion of biological diversity world-wide led to the establishment and adoption of the Convention on Biological Diversity (CBD) in 1992. This Convention recognizes the sovereign rights of the states over their biological resources. Taking the Convention's provisions and to deal with management of our biological resources, Government of India has enacted the Biological Diversity Act, 2002. The Act provides for conservation of Biological Diversity, sustainable use of its components and fair and equitable sharing of the benefits arising out of the use of biological resources and knowledge. At the national level, National Biodiversity Authority (NBA) has been established to implement the Act with headquarters in Chennai (Tamil Nadu) under Sec. 8 of the Act. The State Biodiversity Boards (SBBs) are formed at state level and Biodiversity Management committees (BMC) are constituted by the local bodies to decentralize the implementation of the Act.

Assam State Biodiversity Board:

In exercise of powers conferred under sub-section (I) of Section 22 of the Biological Diversity Act, 2002 (Act 18 of 2003), the Government of Assam constituted the "Assam Biodiversity Board" on 29th September 2010 to promote biodiversity conservation in the State of Assam, sustainable use of its components and equitable sharing of benefits arising out of the use of biological resources of the state and traditional knowledge associated with these resources and matters incidental thereto or connected therewith.

Members of the Board:

The present chairman of the Assam State Biodiversity Board (ASBB) is Shri P. P. Varma, IAS, Additional Chief Secretary to the Government of Assam. The Board comprises of five Ex-officio members from related Departments of Government of Assam and five Expert Members from different aspects of biodiversity management.

Ex-Officio Members:

- 1. Principal Secretary/ Commissioner and Secretary to the Government of Assam, Environment and Forest Department.
- 2. Commissioner and Secretary to the Government of Assam, Agriculture Department.
- 3. Chief Conservator of Forests, Biodiversity & Climate Change.
- 4. The Director, Agriculture Department, Government of Assam.
- 5. The Director, Fisheries Department, Government of Assam.

Expert Members:

- 1. Prof. Sarat Borkotoky, Principal, Nowgong College, Nagaon.
- 2. Shri R. C. Goswami, Chief Conservator of Forest (Retd.).
- 3. Dr. P. C. Bhattacharjee, (Retd) Professor, Department of Zoology, Gauhati University.

Functions of the Assam State Biodiversity Board (ASBB):


Without prejudice to the provisions of the Act in general, the Board may perform the following particular functions, viz.

- i. To lay down procedure and guidelines to govern the activities under section 23 of the Act;
- ii. To advise the government on any matter concerning conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resources and associated traditional knowledge;
- iii. To provide technical assistance and guidance to the departments of the State Government;
- iv. To regulate by granting of approvals or otherwise, on requests for commercial utilization or bio-survey and bio-utilization of any biological resource by Indian Nationals;
- v. To facilitate in updating and implementation of State Biodiversity Strategy and Action Plan;
- vi. To constitute expert committee consisting of experts and persons having local knowledge, commission studies and sponsor investigation and research;
- vii. To engage consultants for a specific period, not exceeding three years, for providing technical assistance to the Board in the effective discharge of its functions: provided that if it is necessary and expedient to engage any consultant beyond three years, the Board shall seek prior approval of the Government for such an engagement;

- viii. To collect, compile and publish technical and statistical data, manuals, codes and guidelines relating to conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;
- ix. Inventorization, cataloguing of biodiversity, monitoring the rate of depletion, awareness creation in public, decision makers and planners and initiating scientific, administrative, legal and socio-economic measures for the protection of biodiversity;
- x. To compile a database on the biodiversity resources in the State,
- xi. Development of state wide strategy for implementing biodiversity programmes;
- xii. To identify the natural habitat of useful biological communities by enlisting the services of the locally available experts;
- xiii. Preparation of an exhaustive inventory of the species available in the natural habitat of useful biological communities and take steps to preserve them,
- xiv. To take steps to build up database and to create information and documentation system for biological-resource and associated traditional knowledge through biodiversity registers and electronic database to ensure effective management, promotion and sustainable uses;
- xv. To devise methods to ensure protection of rights including intellectual property rights over biological resources and associated knowledge including systems of maintaining confidentiality of such information as appropriate including protection of information recorded in People's Biodiversity Register;
- xvi. To ensure that biodiversity and biodiversity dependent livelihoods are integrated into all sectors of planning and management and at all levels of planning from local to state to enable such sectors and administrative levels to contribute effectively for conservation and sustainable use;

- xvii. To plan and organize training programmes for personnel engaged or likely to be engaged in programmes for the conservation of biological biodiversity and sustainable use of its components;
- xviii. To generate public awareness for conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;
- xix. Setting up sufficient infrastructure and strengthening technology base in biochemistry and biotechnology including molecular systematizer;
- xx. Preparation of annual budget of the Board incorporating its own receipts as also devolution from the Central and the State Governments and the National Biodiversity Authority;
- xxi. To recommend creation of posts to the Government for the effective discharge of functions by the Board and to create such posts:
- xxii. Provided that no such posts of any nature, whether temporary or permanent, shall be created without the prior approval of the Government,
- xxiii. To approve the method of recruitment to such posts;
- xxiv. To co-ordinate the activities of the Biodiversity Management Committees,
- xxv. To give directions to Biodiversity Management Committees in writing and through appropriate oral means for effective implementation of the Act and to facilitate their meaningful participation in all measures relating to conservation, sustainable use and equitable benefit sharing,
- xxvi. To report to the Government and the National Biodiversity Authority about the functioning of the Board and Implementation of the Act,
- xxvii. To recommend, prescribe or modify collection fee of biological resources from time to time;



- xxix. To undertake physical inspection of any area within its jurisdiction in connection with the implementation of the Act;
- xxx. To do such other functions as may be directed by the State Government from time to time.

Setting up of Board Office:

After the notification of the Board in 2010, the Assam State Biodiversity Board was working from the Office of the Principal Chief Conservator of Forest, Rehabari till February 2012. With the help of infrastructure development grant from National Biodiversity Authority (NBA), Chennai, the Independent Office of the Assam State Biodiversity Board has been set up at Paryatan Bhawan, 1st Floor, A. K. Azad Road, Rehabari, Guwahati- 781008 in March 2012. Since then, the Board has been functioning from this office.

Staff of the Board:

ASBB with the help of staffing support from NBA was able to appoint two contractual staffs during the year 2011-12 as below:

- " Steno-cum Personal Secretary 1
- " Dak runner-cum Office Attendant 1

Board Meetings:

Ever since its inception the Board has been having its quarterly meetings to take its mandate forward. Accordingly, three Board Meetings were held during the year 2011-12:

1st Board Meeting:

The First Board meeting of the Board was held on 11th August, 2011 at the Conference Hall, 3rd floor, F-Block, Assam Secretariat, Dispur.

Key Issues of the Meeting:

- 1. Discussions on the Assam Biodiversity Rules, 2010.
- 2. Framing of necessary guidelines for operationalising Assam Biodiversity Rules, 2010.
- 3. Budget of Assam State Biodiversity Board.



- 4. Sensitization of Policy planners and administrators.
- 5. Opening of Bank account of Assam State Biodiversity Board.
- 6. Office space and supporting staffs of the Board.

2nd Board Meeting:

The Second Board meeting was held on 16th November, 2011 at the Conference Hall, 3rd floor, F-Block, Assam Secretariat, Dispur.

Key Issues of the Meeting:

1. Actions taken report:

The following issues were discussed:

- a. Seeking comments on Assam Biodiversity Rules-2010.
- b. A Proposal to be submitted for Corrigendum with respect to Para 31 of the Rules wherein it has been mentioned "Assam Biodiversity Rules 2008" instead of "Assam Biodiversity Rules 2010".
- c. Assamese version of the Act and Rules.
- d. Issue of framing suitable guidelines for implementation of Assam Biodiversity Rules.
- e. Approval of Government of Assam for opening of an account of the ASBB in a Nationalized Bank. Bank account will soon be opened.
- f. Office space for the Board has not been finalized as yet.

2. ASBB Website:

There is a need to have wider consultations with varied stakeholders in the functioning of the Board. At the same time, for the sake of transparency, it is also necessary to put in the public domain various actions / activities contemplated and taken by the Board. For this purpose it is necessary to create a bilingual website of the ASBB. It is proposed that the Board may consider launch of a website of the ASSB by engaging a professional designer and taking cue from the existing websites of other States.

3. ASBB Logo:

Board approval for designing of a Logo for the ASBB.

4. Support Staff of the Board:

To begin with the Board also needs some support staff for its day to day functioning. Later on the Board would also require services of subject matter specialists/consultants for undertaking specific assignments. For the present the Board may allow hiring of following support staff on contractual basis:

- a. UDA / Accounts Person- 1
- b. LDA / Data Manager -1
- c. Computer Operators -2
- d. Peon / Dak Runner-1
- 5. Budget for the Board:

The Government of Assam have not made any allocation in the Budget for the ASSB. The Board will not be able to meet any of its objectives if necessary financial support is not forthcoming. The Board may consider appropriate strategy / action in this regard.

6. Immediate tasks before the Board:

- a. Constitution of Biodiversity Management Committees is the foremost requirement for implementing biodiversity Rules. These Committees are to be constituted by the local bodies. The Forest Department can play a significant role in this process. A State level Workshop for sensitization of the forest officials can be helpful. The Board may consider and recommend suitable strategy for initiation and timely completion of the task.
- b. The three major Autonomous Councils may require different strategy for constitution of BMCs. The Board may like to specifically discuss this matter and consider appropriate action.
- c. The Board may also like to prioritize further actions such as creation of Peoples' Biodiversity Registers, initiation of biodiversity inventory, study existing and potential commercially exploitable bioresources and creation of expert groups if considered necessary.
