OVERVIEW OF THE BOARD

Introduction

Biodiversity refers to the variety of life forms at all levels of organization, from gene through species to higher taxonomic forms and includes the variety of ecosystems and habitats besides the processes occurring therein. Biodiversity is fundamental to the fulfillment of human needs -

a biodiversity rich region offers wide options and opportunities for sustaining human welfare including adaptation to changes.

India is one of the 17 Mega biodiverse countries in the world (as per Conservation International 1998) and accounts for 7-8 % of the recorded species. North-eastern India in general and Assam in particular is a constituent unit of the Eastern Himalayan Biodiversity Region; one of the two biodiversity "Hot Spots" in the country. The State also falls in the transitional zone between the Indian, Indo-Malayan and Indo-Chinese Biogeographical regions. The climatic condition and wide variety of physical features witnessed in Assam have resulted in a diversity of ecological habitats such as forests, grasslands, wetlands, which harbour and sustain wide ranging flora and fauna. About 37.27% of State's geographical area is under green cover (as per India State of Forest Report 2015). The Protected Area Network of the State comprises of 5 National Parks and 20 Wildlife Sanctuaries. Besides, Assam has the distinction of having 2 UNESCO World Heritage sites (Manas And Kaziranga), 2 Biosphere Reserves (Dibru-Saikhowa and Manas), 3 Tiger Reserves (KNP, Manas and Nameri) and 5 Elephant Reserves.

There has been a growing concern worldwide for depletion of biological diversity, which led to the establishment and adoption of the Convention on Biological Diversity (CBD) in 1992. This Convention recognizes the sovereign rights of the states over their biological resources. With this objective the Government of India enacted the Biological Diversity Act, in 2002. This Act provides for conservation of biological diversity, sustainable use of its components and fair and equitable sharing of the benefits arising out of commercial use of biological resources and associated traditional knowledge. At the national level, National Biodiversity Authority (NBA) oversees implementation of the Act. The State Biodiversity Boards (SBBs) are formed at state level and **Biodiversity Management** Committees (BMC) are constituted by the local bodies to decentralize the implementation of the Act.

Assam State Biodiversity Board:

The Government of **Assam constituted** "Assam Biodiversity Board" on 29th September 2010 as per Section-22(1) of the **Biological Diversity Act-**2002 (Act 18 of 2003) to promote biodiversity conservation, sustainable use of its components besides equitable sharing of benefits arising out of the use of biological resources and its associated traditional knowledge.

Composition of the Board:

The Board is headed by a Chairman in the rank of Additional Chief Secretary to the Government of Assam. During the year 2014-15, Shri Subhash Chandra Das, IAS, held the Chairmanship of the Board. Apart from the Chairman, the Board has six Ex-officio members from related Departments of Government of Assam and five Expert Members. The officer in-charge of Biodiversity in the Forest Department is the Member Secretary to the Board.

Functions of the Assam State Biodiversity Board

Without prejudice to the provisions of the Act in general, the Board has following functions:

- i. To lay down procedure and guidelines to govern the activities under section 23 of the Act;
- ii. To advise the government on any matter concerning conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resources and associated traditional knowledge;
- iii. To provide technical assistance and guidance to the departments of the State Government;
- iv. To regulate by granting of approvals or otherwise, on requests for commercial utilization or bio-survey and bio-utilization of any biological resource by Indian Nationals;
- v. To facilitate in updating and implementation of State Biodiversity Strategy and Action Plan;
- vi. To constitute expert committees consisting of experts and persons having local knowledge, commission studies and sponsor investigation and research;
- vii. To engage consultants for a specific period, not exceeding three years, for providing technical assistance to the Board in the effective discharge of its functions: provided that if it is necessary and expedient to engage any consultant beyond three years, the Board shall seek prior approval of the Government for such an engagement;
- viii. To collect, compile and publish technical and statistical data, manuals, codes and guidelines relating to conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;
- ix. Inventorization, cataloguing of biodiversity, monitoring the rate of depletion, awareness creation in public, decision makers and planners and initiating scientific, administrative, legal and socio-economic measures for the protection of biodiversity;
- x. To compile a database on the biodiversity resources in the State,

- xi. Development of state wide strategy for implementing biodiversity programmes;
- To identify the natural habitat of useful biological communities by enlisting xii. the services of the locally available experts;
- xiii. Preparation of an exhaustive inventory of the species available in the natural habitat of useful biological communities and take steps to preserve them,
- xiv. To take steps to build up database and to create information and documentation system for biological resources and associated traditional knowledge through biodiversity registers and electronic database to ensure effective management, promotion and sustainable uses;
- To devise methods to ensure protection of rights including intellectual XV. property rights over biological resources and associated knowledge including systems of maintaining confidentiality of such information as appropriate including protection of information recorded in People's Biodiversity Register;
- To ensure that biodiversity and biodiversity dependent livelihoods are integrated into all sectors of planning and management and at all levels of planning from local to state to enable such sectors and administrative levels to contribute effectively for conservation and sustainable use;
- xvii. To plan and organize training programmes for personnel engaged or likely to be engaged in programmes for the conservation of biological biodiversity and sustainable use of its components;
- xviii. To generate public awareness for conservation of biological diversity, sustainable use of its components and fair and equitable sharing of benefits arising out of the use of biological resource and knowledge;
- xix. Setting up sufficient infrastructure and strengthening technology base in biochemistry and biotechnology including molecular systematizer;
- Preparation of annual budget of the Board incorporating its own receipts as XX. also devolution from the Central and the State Governments and the National Biodiversity Authority;

- xxi. To recommend creation of posts to the Government for the effective discharge of functions by the Board and to create such posts:
 - a. Provided that no such posts of any nature, whether temporary or permanent, shall be create without the prior approval of the Government,
 - b. To approve the method of recruitment to such posts;
- xxii. To co-ordinate the activities of the Biodiversity Management Committees,
- xxiii. To give directions to Biodiversity

 Management Committees in writing and through appropriate oral means for effective implementation of the Act and to facilitate their meaningful participation in all measures relating to conservation, sustainable use and equitable benefit sharing,
- xxiv. To report to the Government and the National Biodiversity Authority about the functioning of the Board and Implementation of the Act,
- xxv. To recommend, prescribe or modify collection fee of biological resources from time to time;
- xxvi. To sanction grants-in-aid and grants to the Biodiversity Management Committees for specific purposes;
- xxvii. To undertake physical inspection of any area within its jurisdiction in connection with the implementation of the Act;
- xxviii. To do such other functions as may be directed by the State Government from time to time.

MAJOR ACTIVITIES OF THE BOARD DURING THE YEAR 2014-15

I. Biodiversity Management Committees (BMC):

a. Constitution:

The Board constituted 32 new Biodiversity Management Committees (BMCs) during 2014-15 covering 7 Districts namely Dhubri, Bongaigaon, Jorhat, Sivasagar, Dibrugarh, Tinsukia and Karimganj. A list of the newly constituted BMCs are given at Annexure-I.

b. Strengthening of the new Biodiversity Management Committees (BMC):

With a view to strengthen and operationalize the newly constituted BMCs of the above mentioned 7 Districts, the following financial assistance was provided:

- i. As amount of Rs 5000/BMC has been provided for opening of BMC accounts and setting up of BMC office.
- ii. An amount of Rs 20,000/ has been provided to each Forest Division for organizing Divisional and Sub-divisional level awareness workshops for members of the newly constituted BMCs.

II. People's Biodiversity Registers (PBR):

a. Completed PBR:

A total of 6 PBRs including 1 District Level and 5 Anchalik Panchayat Level PBRs of Nagaon District namely Dhalpukhuri, Koliabor, Khagorijan, Lowkhowa and Pakhimoria Anchalik Panchayat BMCs are completed during the year 2014-15. The PBRs are duly vetted by the District Technical Support Group for correctness and completeness. The task was assigned to the Society for Socio-Economic Awareness & Environment Protection (SSEAEP), Nagaon after competitive bidding in the previous financial year.



b. Financial Assistance for preparation of PBR:

An amount of Rs 50,000/ BMC has been sanctioned to 68 BMCs for starting the work of preparation of PBR during 2014-15. The following are the District-wise number of BMCs where the financial assistance for preparation of PBR has been sanctioned:

c. PBR Digital Database:

The Board with the help of AMTRON has developed, a Digital Format for the State Level Biodiversity Database. This database is proposed to be linked with PBRs for generating information both for conservation of biodiversity and for disposal of proposals seeking access to biological resources in the State. The database is in progress.

d. Biodiversity Research Associate Programme (BRAP):

The Board with a view to assist the BMCs in preparation of PBR, launched a new programme called Biodiversity Research Associate Programme (BRAP) during 2014-15. Under the Programme, B.Sc. /M.Sc. Life Sciences Students were engaged for short duration, with a view to allow the interested persons an opportunity to utilize their free time (summer vacations / winter vacations / time between two semesters / time while preparing for competitive exams etc.) and work productively in the field of biodiversity.

i. Objective of the Programme:

To inculcate scientific temper amid the youth in the state of Assam and provide them an opportunity to work for conservation of biodiversity. This program would enhance the understanding of the Associate about the present day challenges in the field of conservation and sustainable use of biodiversity, besides enabling them to meet those challenges.

ii. Time duration:

Program is for short duration (3 - 6 months).

iii. Fellowship:

- a. For 3 months Program (Rs 5,000/- pm + total contingency of Rs 10,000/- towards field visits, documentation etc.)
- b. For 6 months Program (Rs 5,000/- pm + total contingency of Rs 20,000/- towards field visits, documentation etc.)

For the FY 2014-15, 3 Fellows under the Program have been engaged to assist BMCs of Hajo Anchalik Panchayat, Kamrup District and Mayong Anchalik Panchayat, Morigaon District in preparation of their PBR and BMC management plans.

III. Sensitization Workshops:

The Board organizes Zonal and Divisional Level Workshops from time to time for sensitization of BMC and Panchayat members about the Biological Diversity Act-2002, Assam Biodiversity Rules-2010, besides the roles and responsibilities of **Biodiversity Management Committees in** implementation of the Act.

- a. Divisional Level Workshops:
 - The following four workshops were organized during the year 2014-15:
 - i. 25th June, 2014: Divisional Workshop for Dhemaji District at DRDA conference hall in collaboration with office of Conservator of Forests, Northern Assam Circle.

- ii. 14th July, 2014: Divisional Workshops for Sivasagar & Jorhat Districts at Forest Range Office, Sivasagar in collaboration with Office of Conservator of Forests, Eastern Assam Circle.
- iii. 15th July, 2014: Divisional Workshop for Dibrugarh District at DFO Office, Dibrugarh in collaboration wit Office of Conservator of Forests, Eastern Assam Circle.
- iv. 24th August, 2014: Divisional Workshop for Sonitpur District at Biswanath Chariali, Tezpur in collaboration with Office of Conservator of Forests, Northern Assam Circle.

More than 100 participants from BMCs of the respective districts, representatives from panchayats, members of local NGOs and experts attended these workshops.

b. Zonal Level Workshop:

A Zonal workshop was held on 30th October, 2014 for Dima Hasao Autonomous Council at Additional Principal Chief Conservator of Forests office, Dima Hasao, Haflong. Around 80 **Delegates including Senior Government** Officers from Forest, Agriculture, Horticulture, Fisheries, Education & Research Departments, representatives of Panchayats, Prominent Local NGOs and Eminent Citizens of the Council took part in the workshop.

c. Other Sensitization Workshops/Seminars/Meetings:

- i. A meeting of Board Members and other stakeholders with the Chief Secretary to the Government of Assam, Shri Jitesh Khosla, IAS was held on 19/09/2014 to discuss the mandate of the Board, its progress and associated constraints.
- ii. A Participatory Rural Appraisal (PRA) exercise meeting cum workshop for Hajo Block BMC was held on 16/10/2014, wherein, Member Secretary-ASBB, Board Staff and BRAP Fellows demonstrated PRA exercise to the BMC and Panchayat members.

The members of BMCs, Technical Support Group (TSG), local village people, Forest Department and local media were present at the workshop wherein the TSG members vetted five (5) PBRs of Nagaon District prepared by SSEAEP, Nagaon.




