## **Terms of Reference**

### **Introduction:**

The Assam State Biodiversity Board (ASBB) was established on 29<sup>th</sup> of September 2010 by the Government of Assam with the principal aim of promoting biodiversity conservation in the state of Assam, sustainable use of its components and equitable sharing of benefits arising out of its components and equitable sharing of benefits arising out of the use of biological resources of the state and its associated traditional knowledge. Under the provisions of the Biological Diversity Act 2002 and the Assam Biodiversity Rules 2010. The ASBB serves the following major functions:

1. Generate awareness among local people about the Biological Diversity Act-2002 and Assam Biodiversity Rules-2010.
2. Establish Biodiversity Management Committees (BMCs) at District level, Anchalik Panchayat (Block) level, Panchayat level, Municipal Board, Municipal Corporation and also in the Autonomous Councils of the State.
3. Assist the BMCs in preparation of People's Biodiversity Registers (PBR) through documentation of local biological resources and associated traditional knowledge.
4. Regulate access to biological resources for research and commercial purposes to facilitate 'Access and Benefit Sharing' mechanisms.
5. Declaration of biodiversity rich areas of the state as 'Biodiversity Heritage Sites' and to frame rules for management and monitoring of such sites for conservation.
6. Notification of "Threatened Species" of the State.
7. Approve/regulate commercial use of bioresources of the state or bio-diversity by Indian nationals.
8. Assist and advise Govt. on conservation of Biodiversity of the State, sustainable use and fair benefit-sharing.
9. Other such actions required for implementation of the Biological Diversity Act-2002 in the State.

At present, a total of 2549 BMCs have been constituted in the State at all local bodies/level including 40 BMCs at forest range jurisdiction at the 3 Autonomous Councils (i.e. Bodoland Territorial Council, Dima Hasao Autonomous Council & Karbi Anglong Autonomous Council) of the State.

As per Section-41 of the Biological Diversity Act-2002 and Rule-25(9) of the Assam Biodiversity Rules 2010, each BMC needs to prepare a People's Biodiversity Register (PBR). A PBR is a comprehensive database of information on the availability and knowledge of the local biological resources, their medicinal values or any other associated traditional knowledge.

The Access & Benefit Sharing (ABS) mechanism is a legal regulatory framework under the Biodiversity Diversity Act-2002 to regulate activities of commercial utilization, research, bio-survey and bio-utilization of biological resources occurring in or obtained from India. It secures fair and equitable share in the benefits arising out of the access and utilization of biological resources for commercial purposes. Thus, the benefit secured are channeled to the benefit claimers and for the conservation of biological diversity. Documentation of tradable bioresources in the PBR also helps in the identification of a beneficiary with whom benefits can be shared when an Access and Benefit Sharing (ABS) agreement becomes operational.

Therefore, Assam State Biodiversity Board invites applications from eligible candidates for the engagement of 'Project Assistant' for assisting the ongoing mandated works of implementation Biological Diversity Act & Rules in Assam.

- I. **Duration of Engagement:** 11 months
- II. **Remuneration of the Positions:** Rs. 25,000/- per month and travelling allowance, as per applicable ASBB norms.
- III. **Work location:** Guwahati, but occasional travelling is required within Assam.
- IV. **Domicile:** Resident of Assam
- V. **Age limit:** 21-35 years
